***About the Organization***

[Perinatal Support Washington](#) (PS-WA) is a statewide non-profit committed to shining a light on perinatal mental health to support *all* families and communities. Our vision: All parents receive appropriate, timely, and culturally relevant mental health care during the perinatal period.

Our core programs include a Warm Line that provides families experiencing perinatal mental health complications, peer or professional support, free and low-cost new parent support groups, training and consultation for health care providers, and state-wide advocacy.

***About the current opportunities***

Perinatal Support Washington is growing fast and we have new programs beginning in Fall 2020 and Winter 2021. We are looking for perinatal mental health specialists to join our team.

Washington State Approved Supervisors:

We are seeking 1-2 WA state approved supervisors (for MSWs) who have experience working with interns and providing clinical supervision for therapists working towards licensure. Supervision opportunities include both consistent weekly opportunities and also project based opportunities (i.e. facilitating a consult group for 10 weeks ).

Trainers:

PS-WA is looking to expand our training team. We are looking for perinatal mental health specialists who also have a specialization in one or more of the following areas- perinatal loss, infant mental health, substance use disorders, birth trauma, or medication management. Providers of color, providers from LGBTQIA communities, and providers who speak a language other than English are encouraged to apply.

Perinatal Support WA is looking for experienced trainers to join our team who are also open to training and mentoring those developing their training skills.

**Qualifications**

- Master's Degree or higher (preferably LICSWs)
- 5 or more years specializing in perinatal mental health
- Demonstrated speaking and training experience as evidenced by CV, recorded training, or references.
- Specialization in perinatal mental health *and* one of the subspecialties listed above.

If applying for supervision role:

- WA State Approved Supervisor for MSWs
- 3 or more years of supervision experience

**Compensation and Benefits**

Perinatal Support Washington provides ample opportunity for professional growth and training in perinatal mental health. All current opportunities are for very part time and project based contractors. Hourly rates are highly variable based on grant or project.
