Description of procedures: Student Intern Stipends: All student interns begin receiving a monthly stipend at the completion of the first month of their internship with Perinatal Support Washington. Their supervisor confirms the amount, start and end date with the operations team. Any forms needed, such as a W-9, are provided prior to the scheduling of their first payment. Payments are then scheduled through the organization's bank bill pay system and are monitored by the operations team. Gift Cards and Emergency supplies for families: We give out gift cards to families that we serve. There is qualification criteria for both alongside limitations. Part III, Line 4a: Training - We continued to train providers serving families in the Perinatal period on Perinatal Mental Health, with an increased focus on community-led development. Development for culturally matched training began with 3 focus communities: the LGBTQ+ Community, the Native Hawaiian/Pacific Islander Community, and the Latinx/Spanish Speaking Community. In 2024 we acquired the nonprofit organization Parent Support of Puget Sound. This organization solely focused on perinatal loss. This has allowed us to increase services to families experiencing loss with renewed resources and tools. We also hosted their longstanding Walk to Remember event.
